<p>PURPOSE OF THE SURVEY The purpose of this survey is to obtain information on the supply of, and demand for, energy in Canada. This information serves as an important indicator of Canadian economic performance and is used by all levels of government in establishing informed policies in the energy area. In the case of public utilities, it is used by government agencies to fulfil their regulatory responsibilities. The private sector also uses this information in the corporate decision-making process.</p>		
<p>CONFIDENTIALITY Statistics Canada is prohibited by law from publishing any statistics which would divulge information obtained from its surveys that relates to any identifiable business. The data reported must be treated in strict confidence, used for statistical purposes and published in aggregate form only. The confidentiality provisions of the Statistics Act are not affected by either the Access to Information Act or any other legislation. An exception to the general rule of confidentiality under the Statistics Act is the disclosure, at the discretion of the Chief Statistician, of identifiable information relating to the public utilities, which includes undertakings supplying petroleum or petroleum products by pipeline, and undertakings supplying, transmitting or distributing gas, electricity or steam. This applies to the dissemination of survey results at the provincial or territorial level where only one or two public utilities may have reported data or where one dominates the industry in a particular province or territory, and to the dissemination of technical information for utilities at the location level.</p>		
<p>DATA SHARING AGREEMENTS To reduce response burden and to ensure uniform statistics, Statistics Canada has entered into data sharing agreements with various agencies and government departments for the joint collection and sharing of data from this survey. The information provided in this survey pertaining to individual respondents cannot be divulged, in any way, by the parties with which Statistics Canada has agreements. Agreements exist under section 11 of the <i>Statistics Act</i> to share information with the statistical agencies of Nova Scotia, Québec, Saskatchewan and Alberta regarding business establishments located or operating in their respective province. These provincial statistical agencies have been established under provincial legislation authorizing them to collect this information on their own or jointly with Statistics Canada. The provincial legislation in those four provinces also contains the same confidentiality protection and outlines similar penalties for disclosure of confidential information as the federal <i>Statistics Act</i>. Agreements exist under Section 12 of the <i>Statistics Act</i> with Natural Resources Canada and the National Energy Board. Section 12 agreements shall not apply to your return if an officer of your company objects in writing to the Chief Statistician and mails the letter to the Manufacturing, Construction and Energy Division of Statistics Canada together with the completed questionnaire. Please specify the agency or association listed above from which data shall be withheld.</p>		
<p>DATA DISEMINATION Data from this survey, including technical information, are disseminated in the Statistics Canada publication "Electric Power Generating Stations" (Catalogue No. 57-206-XIB). If you object, please notify the Manufacturing, Construction and Energy Division of Statistics Canada in writing and return your letter of objection, together with the completed questionnaire.</p>
