GENERAL INFORMATION

Survey purpose

This survey asks questions about commercial stocks of raw **unprocessed** corn for grain and soybeans, stored in your company's elevators. These products may be for your company's use or to be sold to grain or oilseed procession companies for human or animal consumption, or for indus rial use. The data are also used by Agriculture and Agri. Food Canada (AAFC) and by grain analysts in the public and private sectors.

Confidentiality

Your answers are confidential.

Statistics Canada is prohibited by law from releasing any information it collects which could identify any person, business, or organization, ruless consent has been given by the respondent or as pennitued by the *Statistics Act*. The confidentiality provisions of the *Statistics Act* are not affected by either the *Access to Information Act* or any other legislation. Therefore, for example, the Canada Revenue Agency cannot access identifiable survey records from Statistics Canada.

Information from this survey will be used for statistical purposes only and will be published in aggregate form only.

Record linkages

To enhance the data from this survey, Statistics Canada may combine it with information from other surveys or from administrative sources.

Data-sharing agreements

To vo.d duplication of enquiry, Statistics Canada has entered it to data-sharing agreements with provincial statistical acencies, which must keep the data confidential and use them only for statistical purposes. Statistics Canada will only share data from this survey with those organizations that have demonstrated a requirement to use the data.

Section 11 of the *Statistics Act* provides for the sharing of information with provincial statistical agencies that meet certain conditions. These agencies must have the legislative authority to collect the same information, on a mandatory basis, and the legislation must provide substantially the same provisions for confidentiality and penalties for disclosure of confidential information as the *Statistics Act*. Because these agencies have the legal authority to compel businesses to provide the same information, consent is not requested and businesses may not object to the sharing of their data.

For this survey, there are **Section 11** agreements with the provincial statistical agencies of Quebec and Ontario.

The shared data will be limited to information pertaining to businesses located within the jurisdiction of the respective province.

Disclosure of information transmitted by facsimile or other electronic methods

There could be a risk of disclosure during the facsimile or electronic transmission. However, upon receipt of your information, Statistics Canada will provide the level of protection afforded for all information collected under the authority of the *Statistics Act*.


